**ADMINISTRATIVE ORDER N° 145/PR/MSP/SG/DGSELM/DMTNT/18
Concerning the amendment of Administrative Order N°
039/PR/PM/MSP/SE/SG/SG/DGAS/DSPELM/15 Concerning the Regulation of Packaging and
Labeling of Tobacco Products in the Republic of Chad.**

THE MINISTER OF PUBLIC HEALTH

In light of the Constitution;

In light of Law N° 20/PR/2005 of December 30, 2005, authorizing the ratification of the Framework Convention for Tobacco Control of the World Health Organization;

In light of Law N°10/PR/2010 of June 10, 2010, concerning Tobacco Control;

In light of Decree N°1318/PR/2018 of May 7, 2018, concerning the Nomination of Members of the Government;

In light of Decree N°231/PR/PM/2018 of February 9, 2018, concerning the General Structure of the Government and the Attributions of its Members;

In light of Decree N°1161/PR/PM/MSP/2018 of April 30, 2018, concerning the Organizational Diagram of the Ministry of Public Health;

In light of Administrative Order N° 039/PR/PM/MSP/SE/SG/SG/DGAS/DSPELM/2015 of February 10, 2015, Concerning the Regulation of Packaging and Labeling of Tobacco Products in the Republic of Chad;

Considering the needs of service.

ORDERS:

Administrative Order N°039 of February 10, 2015, cited above is to be amended as follows:

Article 1: **Article 11** is to be replaced by the following provisions:

1st On the front surface, health warnings and other messages are to be placed on the upper part of the packages, or on any of the principal surfaces, if there are more than two.

2nd On the rear surface, health warnings and other messages are to be placed on the lower part of the packages, or on any of the principal surfaces, if there are more than two.

Article 2: Manufacturers and importers of tobacco products are required to enter into compliance with the provisions of the guide for the application of warnings attached to this Administrative Order.

Article 3: Counting from the signing of this Administrative Order, a period of nine (9) months is granted to manufacturers, importers, exporters, distributors and operators of points of sale of cigarettes and cigars to enter into compliance with its provisions.
