AKTA MAKANAN 1983

PERATURAN-PERATURAN KAWALAN HASIL TEMBAKAU  
(PINDAAN) 2014

PADA menjalankan kuasa yang diberikan oleh seksyen 36 Akta Makanan 1983 [Akta 281], Menteri membuat peraturan-peraturan yang berikut:

**Nama**

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kawalan Hasil Tembakau (Pindaan) 2014**.

**Pindaan peraturan 2**

2. Peraturan-Peraturan Kawalan Hasil Tembakau 2004 [P.U. (A) 324/2004], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam peraturan 2 dengan memasukkan selepas takrif “kaunter perkhidmatan” takrif yang berikut:

‘ “kawasan rehat dan rawat” ertinya tempat rehat dan kemudahan yang disediakan oleh Lembaga Lebuhraya Malaysia (LLM), Jabatan Kerja Raya, Pihak Berkuasa Tempatan atau lain-lain agensi yang dinamakan ‘kawasan rehat dan rawat’, ‘R&R’ atau ‘hentian sebelah’;’.

**Pindaan peraturan 11**

3. Subperaturan 11(1) Peraturan-Peraturan ibu dipinda—

(a) dalam perenggan (t), dengan memotong perkataan “atau” di hujung perenggan itu;

(b) dalam perenggan (u), dengan menggantikan noktah dengan perkataan “;atau”; dan

(c) dengan memasukkan selepas perenggan (u) perenggan yang berikut:

“(v) dalam mana-mana bangunan atau tempat permainan kanak-kanak atau taman, termasuk lingkungan 3 meter daripada sempadan tempat itu, di kawasan rehat dan rawat.”.

FOOD ACT 1983

CONTROL OF TOBACCO PRODUCT (AMENDMENT)  
REGULATIONS 2014

IN exercise of the powers conferred by section 36 of the Food Act 1983 [*Act 281*], the Minister makes the following regulations:

**Citation**

1. These regulations may be cited as the **Control of Tobacco Product (Amendment) Regulations 2014**.

**Amendment of regulation 2**

2. The Control of Tobacco Product Regulations 2004 [*P.U. (A) 324/2004*], which are referred to as the “principal Regulations” in these Regulations, are amended in regulation 2 by inserting after the definition “service counter” the following definition:

‘ “rest and recreation area” means the place of rest and facilities provided by the Malaysian Highway Authority (MHA), the Department of Public Works, the Local Authority or other agencies named as ‘rest and recreation area’, ‘R & R’ or ‘lay by’;’.

**Amendment of regulation 11**

3. Sub regulation 11(1) of the principal Regulations is amended—

(a) in paragraph (t) by deleting the word “or” at the end of that paragraph;

(b) in paragraph (u) by substituting for the full stop the word “;or”; and

(c) by inserting after paragraph (u) the following paragraph:

“(v) in any building or playground or garden, including the range of 3 meters from the boundary of the place, in rest and recreation area.”.
