Seeing no referatul approval. E.N. 3554 of 31 March 2008 the National Agency for Programs of the Ministry of Public Health and no. D.G. 1151 of 31 March 2008 House National Health Insurance,

Having regard to the art. 48 para. (3) of Law no. 95/2006 on the reform in health, with subsequent amendments, and the Government Decision no. 357/2008 for the approval of national health programs in 2008,

under art. 281 para. (2) of Law no. 95/2006 with subsequent amendments, the art. 7. (4) of the Government Decision no. 862/2006 on the organization and functioning of the Ministry of Public Health, with subsequent amendments, and art. 17. (5) House of the National Health Insurance, approved by Government Decision no. 972/2006, with subsequent amendments,

Minister of Health and chairman of the House National Security Health issued the following order:

ART 1

Approved technical rules to implement the national health programs in 2008, set out in

Annexes no. 1, 2 and 3 (3A - 3D).

ART 2

(1) This order shall take effect from April 2008.

(2) Funds used in the first quarter of 2008 from the state budget, own revenues of the Ministry of Public Health and the Fund of the single national health insurance programs to finance national health minister in the Order of public health and President of National House of Health Insurance No. 570/116/2007 approving technical rules on the implementation, evaluation and financing of national health responsibilities in monitoring and control, detailing the activities and sub-indicators specific and sanitary units through which they are carried out in 2007, with subsequent amendments, are contained in amounts approved this year for programs.

ART 3

National Health Programs, specialized directions of the Ministry of Public Health, House National Health Insurance, the public health insurance home health care providers, public institutions and nominees will carry out the provisions of this Order .

ART 4

No Annexes. 1, 2 and 3 (3A - 3D) form an integral part of this Order.

ART 5

This order shall be published in the Official Gazette, Part I.

III. 2. THE CONTROL OF TOBACCO CONSUMPTION

Technical Coordination: Pneumoftiziologie Institute "Marius Nasta"

Objective:

- A decrease of tobacco consumption by discouraging smoking and onset smoking encouraging surrender

Activities:

a) Activities conducted at the Institute of Pneumoftiziologie "Marius Nasta" through counseling for smoking cessation:

1. provision of therapy services required to support the waiver smoking, for people who want to stop smoking by doctors with specific training;
2. purchase medicines and appliances for measuring carbon monoxide in the air exhalat necessary supportive therapy surrender smoking, as well as their management;
3. purchase items necessary behavioral therapy to support smoking surrender;
4. development and multiplication of material information about the supportive therapy surrender smoking (prints, videos, CD-ROM);

5. development and multiplication of materials promoting smoking surrender and Stop Smoking Program (printed, audio and video spots, other types of materials);

6. development and multiplication of methodological guide therapy for smoking surrender;

7. continuation and expansion activity Verde Tel Stop Smoking;
8. creating and maintaining an Internet site specific;
9. a TV spot on the harmfulness passive smoking;
10. panotare nationally, both inside buildings and outdoors;
11. organization of training specialists in the health promotion, school doctors, psychologists and other persons involved in activities to promote health, to implement activities at national level in a uniform manner;
12. organization of training with representatives of medical units in order to improve the application of legal provision prohibiting smoking;
13. a study to assess the impact of various measures to control tobacco (cigarettes burn package combined with warnings, price increases cigarette packages and other measures);
14. a study to assess knowledge, attitudes and practices on active and passive smoking among adults and minors;
15. a study to assess knowledge and attitudes relating to the legislative field, in the general population;
16. a study to assess the cost of smoking to the health system in Romania;
17. monitoring and quarterly and annual evaluation of its ongoing activities of the program;

18. the campaign to celebrate World Day without Tobacco (31 May) and National Day without tobacco, in collaboration with other institutes, centers and public health authorities;
19. organization of information activities to combat tobacco consumption, in units of instruction;
20. purchase of materials and objects necessary for the implementation of information, including the awarding ceremony for participants in activities.

b) Activities conducted at the Hospital Clinic of Iași Pneumoftiziologie and Hospital Clinic of Infectious Diseases and Pneumoftiziologie "V. Babeș" Timișoara - Clinic Pneumoftiziologie:

1. development and multiplication of material information about the supportive therapy surrender smoking (prints, videos, CD-ROM);
2. development and multiplication of materials promoting smoking surrender and Stop Smoking Program (prints, video and audio spots);
3. organization of competitions in educational establishments;
4. acquisition of objects and materials Premiers participants in competitions;
5. acquisition of objects and materials for the demonstration to highlight the effects of active and passive smoking.

Indicators of evaluation:

a) physical indicators - quarterly:

- Total number of persons receiving medical care for smoking surrender - 45000;
- Total number of persons receiving medical treatment for smoking surrender - 30,000;
- Total number of people calling the free phone line - 1500;
- Total number of national information campaigns - 3;
- Total number of programs for information-education-communication units and

medical education - 5;

- Total number of studies - 4;
- Total number of persons trained - 200;

b) performance indicators - quarterly:

- Average cost / person who has given assistance to surrender smoking: 320 euro / person;

- Average cost / national information campaign: 250 000 lei;
- Average cost / program in educational establishments: 250 000 lei;
- Cost per study: 25 000 lei;

c) outcome indicators - annual:

- Percentage of people who quit smoking at the end of medical treatment (No people no longer smoke at the end of treatment / no. All persons who received treatment): 50;

- The rate of increase in the number of people calling Tel Verde (no. of calls 2008/nr. Calls in 2007): 1.5.

Indicators will be reported Pneumoftiziologie Institute "Prof. Dr. Marius Nasta" - Counseling Center for smoking cessation, and that ANP report from the Ministry of Public Health.

- Pneumoftiziologie Institute "Marius Nasta" București (through counseling for smoking cessation);
- Pneumoftiziologie Hospital of Iași;
- Hospital of Infectious Diseases and Pneumoftiziologie "V. Babes" Timisoara;
- Public health authorities and councils of the municipality of Bucharest.
