In accordance with Section 5 of Article 12 of the Federal Law, on February 23, 2013, Number 15-FZ "On protection of public health from exposure to tobacco smoke and the consequences of tobacco consumption" (Collection of the Legislation of the Russian Federation, 2013, Number 8, Article 721) and paragraph 5.2.207 (1) The regulations of the Ministry of Health of the Russian Federation, approved by the Government of the Russian Federation on June 19, 2012, No. 608 (Collection of the Legislation of the Russian Federation, 2012, No. 26, art. 3526, 2013, No. 16, art. 1970 No. 20, art. 2477; Number 22, art. 2812; No. 33, art. 4386; No. 45, art. 5822, 2014, No. 12, art. 1296), I hereby order you to:

Approve the accompanying requirements for the sign prohibiting smoking and for the requirements for the rules of its placement.

**Requirements for the sign prohibiting smoking and the requirements for the rules of its placement**

1. The sign prohibiting smoking is to be executed in the form of a specific geometrical shape, using a variety of colors, graphic symbols (a graphic image in color) and is depicted as a circle with a red border (with the exception of an additional sign prohibiting smoking, placed in accordance with the given requirements of paragraph 6; the image may be different, and it may be in a different color); the width shall not be less than 13.7 mm (an amendment to the present requirements). The diameter of the circle shall not be less than 200 mm, including the rim. In the center of the circle, a graphical representation of cigarettes is horizontally placed depicting three black rectangles. The size of the first rectangle shall be at least 120 x 25 mm; the second and third shall not be less than 6.2 x 25 mm. Rectangles are placed from left to right. The distance

between the first and second rectangle shall be at least 5 mm; the distance between the second and third shall not be less than 6.2 mm. Wavy lines depicting smoke with a minimum width of 5 mm are at the top of the second and third rectangles. A cigarette crosses the red horizontal line with a width of at least 17.5 mm. A red horizontal line is executed at an angle of 45 degrees to the horizontal with a slope at the top left of the border right down to the rim and shall not be interrupted by the graphic symbol of the sign (cigarette).

2. The sign prohibiting smoking located in vehicles as well as the sign prohibiting smoking located in accordance with the given requirements of paragraph 6 may be less than the size specified by paragraph 1 of these requirements.
3. The graphic image in color of the sign prohibiting smoking is produced using a variety of technologies to the surface of the base material, including metal, plastic, or organic silicate glass, self-adhesive plastic film, adhesive and printing paper, and cardboard.
4. The slogans "No Smoking," "Smoking is prohibited," and (or) information about the amount of fines for smoking may accompany a sign prohibiting smoking.
5. The sign prohibiting smoking is placed at each entrance of each area, within a building and facility where tobacco smoking is prohibited (for vehicles-on the exterior door), as well as in the common areas, including bathrooms.

In rooms designed to provide hotel services, services for the temporary placement and (or) providing temporary accommodation, a sign prohibiting smoking is additionally located near the place of registration (reception desk).

6. An additional sign prohibiting smoking is placed by the owner of the property or another person authorized by the owner of the property in the areas used for activities, including:
  - a) on the door of the room or in the room (for rooms intended for hotel services, services for temporary accommodation and (or) providing temporary accommodation);
  - b) near the bar, in the halls, including banquet halls, cabins and rooms (for rooms intended for providing retail services, catering, and market facilities);
  - c) on the platform (for trains);
  - d) in the cabin (for aircraft).
