Article 129. Involvement of minors in the use of *tobacco products*, alcoholic beverages or intoxicants
(Law of the Republic of Tajikistan No. 717 of June 28, 2011)

1. The involvement of minors in the use of *tobacco products*, alcoholic beverages or intoxicants, including narcotics, psychotropics or their precursors, with no signs of a crime, **(Law of the Republic of Tajikistan No. 717 of June 28, 2011)**
 - is punishable by a fine from five to ten units for calculations.
2. The same action committed by parents or other legal representatives of minors and persons responsible for their education, upbringing and treatment,
 - is punishable by a fine from twenty to thirty units for calculations.

Article 463. Drinking alcoholic beverages or smoking *tobacco products* in public places
(Law of the Republic of Tajikistan No 717 of June 28, 2011)

1. Drinking alcoholic beverages on the street, in stadiums, squares, parks, on all types of public transport and in other public places or appearing in public places while intoxicated, offending human dignity, public morals,
 - are punishable by a fine of three to five units for calculations.
2. The same actions, stipulated by part one of this article, committed repeatedly within one year after application of an administrative penalty,
 - are punishable by a fine from three to five units for calculations.
3. *Smoking tobacco products, including Nasa inside administrative buildings, in the offices of governmental and non-governmental organizations, health care, cultural, religious, sports and educational facilities, sanatoriums, halls where social and cultural events are held, airport lounges, train stations and highway rest stops, as well as on public transport, except for specially designated places for this, (Law of the Republic of Tajikistan No. 717 of June 28, 2011)*
 - is punishable by a fine of between one and two units for calculations.

Article 463¹. Sale of cigarettes, cigars, *papirosy* and other tobacco products on the territories and around health care, cultural, physical education and sports and educational institutions, as well as with the use of machines

1. *The sale of cigarettes, cigars, papirosy and other tobacco products on the territory and around health care, cultural, physical education and sports and educational institutions, as well as at a distance of less than one hundred meters from the borders of educational institutions,*
 - is punishable by a fine for individuals in an amount from three to five units and for legal entities in an amount from one hundred to two hundred units for calculations.
2. *The sale of cigarettes, cigars, papirosy and other tobacco products using machines,*

– is punishable by a fine for individuals in an amount from five to seven units for calculations and for legal entities in an amount from one hundred fifty to two hundred fifty units for calculations.

Article 463². Sale of cigarettes, cigars, papirosy and other tobacco products to minors

The sale of cigarettes, cigars, papirosy **and** other tobacco products to minors,
– is punishable for individuals in an amount from five to seven units for calculations and for legal entities **in** an amount from thirty to fifty units for calculations.

Article 463³. Prohibition on the production, import, export, wholesale and retail sale of tobacco products, with a composition of nicotine and tar exceeding the approved hygiene standard, as well as the absence on the package of the main and additional warning labels about the danger of smoking

1. The production, import, export, wholesale and retail sale of tobacco products, with a composition of nicotine and tar exceeding the hygiene standards approved by the authorized state health care agency,
– is punishable by a fine for individuals in an amount from five to ten units for calculations and for legal entities from two hundred to three hundred units for calculations.”

2. The absence on the front and back and sides of the package of the main and additional warning labels about the danger of smoking and information labels on the standards for the content of tar and nicotine in them,
– is punishable by a fine on individuals in an amount from ten to fifteen units for calculations and for legal entities in an amount from two hundred fifty to three hundred units for calculations.

Article 549. Advertising of alcoholic beverages, tobacco and tobacco products

Violation of the standards and rules for advertising of alcoholic beverages, tobacco and tobacco products established by the Law of the Republic of Tajikistan “On Advertising” -

is punishable by a fine for officials in an amount from eighty to one hundred and for legal entities – from four thousand to five thousand units for calculations.

Article 639. Import and sale of tobacco products and alcoholic beverages without excise stamps

The import and sale of tobacco products and alcoholic beverages without excise stamps,
– are punishable by a fine for individuals in an amount from ten to twenty, for officials – from eighty to one hundred and for legal entities – from one to two thousand units for calculations with confiscation of the subject of the administrative offense.
