About Introduction
of Changes and Amendments
to the Code of the Republic of Uzbekistan
ABOUT ADMINISTRATIVE LIABILITY

Adopted by the Legislative Chamber on February 13, 2008
Approved by the Senate on March 27, 2008

Article 1. To introduce to the **Code of the Republic of Uzbekistan about Administrative Liability**, approved with the Law of the Republic of Uzbekistan dated September 22, 1994, N 2015-XII (Vedomosty (Bulletin) of the Supreme Soviet of the Republic of Uzbekistan, 1995, N 3, page 6; Vedomosty Oliy Majlis of the Republic of Uzbekistan, 1995, N 9, page 193, N 12, page 269; 1996, N 5-6, page 69, N 9, page 144; 1997, N 2, page 56, N 4-5, page 126, N 9, page 241; 1998, N 3, page 38, N 5-6, page 102, N 9, page 181; 1999, N 1, page 20, N 5, page 124, N 9, page 229; 2000, N 5-6, page 153, N 7-8, page 217; 2001, N 1-2, page 23, N 9-10, pages 165, 182; 2002, N 1, page 20, N 9, page 165; 2003, N 1, page 8, N 5, page 67, N 9-10, page 149; 2004, N 1-2, page 18, N 5, page 90, N 9, page 171; 2005, N 1, page 18; Vedomosty of Chambers of Oliy Majlis of the republic of Uzbekistan, 2005, N 9, page 312, N 12, pages 413, 417, 418; 2006, N 6, page 261, N 9, page 498, N 10, page 536, N 12, pages 656, 659; 2007, N 4, pages 158, 159, 164, 165, N 9, pages 416, 421, N 12, pages 596,604, 607), the following changes and amendments:

1) Article 9:

to add part two:

"Individual who made administrative violation on the vessel under the flag of the Republic of Uzbekistan or registered at port of the Republic of Uzbekistan and that is at open air or water space beyond the territory of the Republic of Uzbekistan, is liable according to the present Code, provided the other is not stipulated by international treaty of the Republic of Uzbekistan";

Part two and three to be considered as part three and four accordingly;

2) Article 117:

in sanction of part one the wording "from one half to one minimum wage" substitute with the wording "from five to ten minimum wages";

in sanction of part two the wording "from one tenth to one half of minimum wage" substitute with the wording "from three to five minimum wages";

3) Article 121:

In sanction of part one the wording "from three to five" substitute with the words "from ten to fifteen";

in sanction of part two the wording "from two to four" substitute with the words "from five to ten";

4) Article 122 to state as follows:

"Smoking in not designated areas in intercity and long distance trains, at river vessels, in carriages (including platforms) of local trains, in municipal, local, intercity buses, and buses of international communication, in taxi, fixed-run taxi and municipal electro transport -

implies penalty in the amount of one twentieth of minimum wage.

Smoking in air transport -

implies penalty in the amount of two minimum wages".

Article 2. The present law comes into force since the day of its official publication.
