**ORDER.**

**ANWAR ZAHEER JAMALI, CJ.-** In view of the explanation

**ATTESTED** submitted by the Secretary Commerce, Government of Pakistan which is

available in Court file as CMA No.6822/2016, the show cause notice issued to him is discharged.

2. On behalf of the Federal Government, Ministry of National Health Services, Regulations and Coordination, a report bearing CMA No.6852/2016 has been placed on record in order to show that the directions of this Court, issued on the subject, have been complied with in letter and spirit.

3. This being the position, instant *suo moto* proceedings stand disposed of, with the observation that the concerned departments in all the provinces shall ensure that the Ban on import and use of flavoured/non flavoured sheesha (tobacco and tobacco free) and related substances is strictly and effectively implemented, so that *Sheesha* smoking culture is not continued further in their respective provinces. However, if any individual has any further grievance in this regard, he may move an appropriate application for resurrection of this matter. It has been pointed out that Constitutional Petitions in respect of use of Sheesha and Tobacco are pending before various High Courts. We are sanguine that such petitions will be decided by the High Courts expeditiously, in accordance with law.

4. All the other pending connected CMAs also stand disposed of.
